A flexible pad used to reinstate the fire resistance performance of wall and floor constructions where they have been provided with apertures for the penetration of insulated or uninsulated metallic pipes, cables, and pipes or cables into socket boxes, on both sides of the wall. The Protecta FR Putty is supplied precut to size with a peel off strip to both faces to prevent it from bonding materials other than for the desired application. The Protecta FR Putty is installed by removing the peelable strips and wrapping the pad around the socket box where it penetrates the face of the wall and covering the back face of the box (at the end of the pipe). When installing around service penetrations, the Protecta FR Putty is installed by removing the peelable strips and wrapping the pad around the service where it penetrates the face of the wall or floor.
